Cover page should contain title of the paper, author's/co-author's names, email address, contact number and active WhatsApp number. Soft copy of the cover page, abstract and full-length research paper should be sent to [nacdaf2023@gmail.com](mailto:nacdaf2023@gmail.com) on or before **24th December 2022**.
