AND

Kashida Fashion Institute, the Second Party, through its Proprietor **Mrs. Trupti Davda**, located at **9/A, Navrang Building, Parekh Lane, Kandivali West, Mumbai 400 067** and engaged in **various educational services**, (hereinafter referred to as "Second Party", proprietorship firm which expression, unless excluded by or repugnant to the subject or context shall include its successors– in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS,

Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives and shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 The general terms of co-operation shall be governed by this MOU.

CLAUSE 2 SCOPE OF THE MOU

- 2.1 Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 Second Party will actively engage to help the delivery of the training and placement of students of the First Party into internships.

CLAUSE 3 OBLIGATIONS OF SECOND PARTY

- 3.1 The Second Party, will at its sole cost and expense:
- 3.1.1. Protect at all times the privacy of the Student/s Data. Further, it will neither directly nor indirectly permit its Representative/s and/or Third Party access, or commercial use of Student/s Data;

CLAUSE 4 VALIDITY

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.
- 4.2 This MOU is for a period of 2 years starting from 22nd June,2018. Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination,

Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

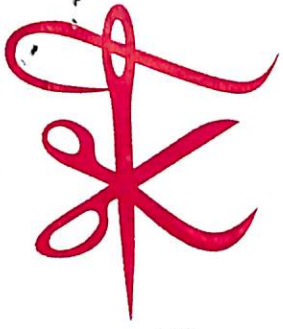
